**NOTICE OF WITHDRAWAL OF OBJECTIONS OF  
CQS ABS MASTER FUND LTD., CQS SELECT ABS MASTER  
FUND LTD. AND CQS ABS ALPHA MASTER FUND LTD. TO PLAN  
OF REHABILITATION FOR FINANCIAL GUARANTY INSURANCE  
COMPANY SUBJECT TO ENTRY OF REVISED PLAN APPROVAL ORDER**

CQS ABS Master Fund Ltd., CQS Select ABS Master Fund Ltd and CQS ABS Alpha Master Fund Ltd. (collectively, “**CQS**”), by and through its undersigned attorneys, respectfully submits the following notice of withdrawal of (i) *Objection of CQS ABS Master Fund Ltd., CQS Select ABS Master Fund Ltd and CQS ABS Alpha Master Fund Ltd. to Plan of Rehabilitation for Financial Guaranty Insurance Company*, dated November 19, 2012 (the “**Plan Objection**”), (ii) *The Amended Objections of CQS ABS Master Fund Ltd., CQS Select ABS Master Fund Ltd and CQS ABS Alpha Master Fund Ltd. to Plan of Rehabilitation for Financial Guaranty Insurance Company*, dated January 22, 2013 (the “**Amended Plan Objection**”), (iii) *Memorandum of Law in Support of the Amended Objections of CQS ABS Master Fund Ltd., CQS Select ABS Master Fund Ltd and CQS ABS Alpha Master Fund Ltd. to Plan of Rehabilitation for Financial Guaranty Insurance Company*, dated January 22, 2013 (the “**Memorandum**”) and (iv) *Affirmation of Thomas M. Mullaney*, dated January 22, 2013 (the “**Affirmation**” and, together with the Plan Objection, the Amended Plan Objection and the Memorandum, the “**Plan Objections**”):

1. On September 27, 2012, the Superintendent of Financial Services of the State of New York, as the court-appointed rehabilitator (the “**Rehabilitator**”) of Financial Guaranty Insurance Company (“**FGIC**”) filed the Plan of Rehabilitation for Financial Guaranty Insurance Company, dated September 27, 2012.

2. On November 19, 2012, CQS filed the Plan Objection.

3. On December 12, 2012, the Rehabilitator filed the First Amended Plan of Rehabilitation for Financial Guaranty Insurance Company, dated December 12, 2012, which addressed certain objections raised by objecting parties.

4. On January 22, 2013, CQS filed the Amended Plan Objection, the Memorandum and the Affirmation.

5. On April 12, 2013, the Rehabilitator filed a revised version of the First Amended Plan of Rehabilitation for Financial Guaranty Insurance Company, dated April 12, 2013 (the “**April 12 Plan**”), which further addressed certain objections raised by objecting parties.

6. Subsequently, CQS participated in discussions with the Rehabilitator to resolve the Plan Objections. As a result, CQS and the Rehabilitator reached agreements regarding certain revisions to the April 12 Plan and the proposed order approving the April 12 Plan (the “**Proposed Plan Approval Order**”), which revisions fully resolve the Plan Objections and are reflected in the First Amended Plan of Rehabilitation for Financial Guaranty Company, dated June 4, 2013, and a revised version of the Proposed Plan Approval Order filed with the Court on June 4, 2013.

WHEREFORE, the Plan Objections are withdrawn with prejudice effective upon entry of the Proposed Plan Approval Order containing the finding in (e) and the ordered language in paragraph 7 and otherwise substantially in the form filed with the Court on June 4, 2013 approving the Plan.
